In addition to CHS there were seven other bands that participated in the halftime show at the bowl. There were several schools from Oklahoma, one from Colorado, one from Arizona and one from Columbus, Georgia.

Peabody said the students received the halftime music several months before the bowl game. He said this gave them time to memorize the music. Peabody said the formation was a simple march onto the field and a simple march off the field.
"In less than six hours of rehearsal, they put together the show," he said.
Peabody said he selected the Alamo Bowl because it is one of the more inexpensive locations.
"I worked very hard to keep it at a reasonable price," he said. "I didn't want to price it out so kids couldn't go. For the most part, kids that wanted to go could go."

He said there were 132 students who went and around 12 who didn't go.
"We had a real nice mix of business and pleasure, which is probably why the students were so well behaved," Peabody said.

San Antonio is a perfect location. He said they had a chance to go to Sea World, to the River Walk, ride on a barge cruise on the River Walk and even go to attend the bowl game.
"If you make it to the Rose Bowl, you don't get tickets to the game," he explained. "We got to go to the game and had nice seats."

The Alamo Bowl featured the Missouri Tigers versus the Northwestern Wildcats with the Tigers winning 30-23. Peabody said when deciding on a bowl, he likes to pick one with Big 12 ties. This way the kids are familiar with the teams.

He said he enjoys taking the students on a trip.
"My favorite part about going to another area is the kids are just having fun and they aren't worried about acting cool or what others think," Peabody said.

In the future, he said he would like to do a smaller trip with perhaps a group like the symphonic band. He said there are a couple of nice trips that would be good experience for the kids. The next "big" trip will be in four years.

## Fall sports round-up

The fall sports season at CHS was led by a successful run to the State Cross County Meet by the boys and girls teams coached by Dave Licari.

The boys team led by seniors Trevor Urkoski, Alex Markham and junior Jon Powell qualified for the state cross country meet for the first time in 19 years finishing seventh as a team. They also finished second overall at the district meet in Seward.

The girls' team with the experience of seniors Jena Schwalenberg, Danielle Archuleta and Carrie Wiese won the district meet and finished as the state runner-up at the state competition in Kearney. Both teams lose key seniors; however, they return good talent on both squads.

The Discoverers football team guided by Coach Craig Williams, in his third year at the helm, finished the season at 5-5 with a state playoff loss to McCook. They were led by seniors Grant Otten, Nathan Hughes and Michael Ziola. With a talented group of underclassmen, the Discoverers figure to build on the successes of the past two years.

The girls golf team led by Coach Anne Robertson again
finished strong with a fifth place finish at the state meet. The Discoverers were led by state medalists senior Sara Thurley $\left(13^{\text {th }}\right)$ and sophomore Morgan Smejkal (tie $\left.13^{\text {th }}\right)$. Amanda Ballweg, Paige Theilen and Shayla Rudy rounded out the state qualifiers.

The Discoverers softball squad with Coach Jack Gutierrez at the helm finished the season with a 13-22 record. A gutty run through the district tournament, battling injuries to key players, ended with a 4-3 loss to Grand Island in the finals. The softball squad was led by seniors Megan Kresha and Ashley Szelag. The team looses some experience but has good talent coming back next season.

The volleyball squad let by Coach Jared Johnson was in a rebuilding year finishing the season at 9-26. The Discoverers were led by seniors Molly Brown, Kerrin Thomas, Rachael Weber, Shelby Hughes, Ashley Meyers and Alecyia Watson. The CHS volleyball squad looks to improve next season with a group of underclassmen.

The Boys Tennis team was led by seniors Jared Ostdiek, David Gokie and Simon Schacher. The Discoverers finished the year at the state tournament placing $17^{\text {th }}$. A young but talented group return to lead Coach Scott Bethune's squad next year.

## North Park earns energy award

North Park Elementary School was the first school in the Columbus area to earn the Energy Star designation.

North Park Elementary School, Loup Power District, and Nebraska Public Power District recently teamed up to apply for the Energy Star honor.

ENERGY STAR is the national symbol for protecting the environment through superior energy performance. The U.S. Environmental Protection Agency (EPA) and the U.S. Department of Energy (DOE) sponsor this award.

Loup and NPPD assisted the school with their application for the Energy Star label, by verifying energy consumption, occupant comfort, and proper lighting and ventilation levels.

To date, some 3,200 buildings nationwide have earned the ENERGY STAR designation with North Park being the first school in Loup's service territory to earn the award.
"North Park Elementary School is pleased to have earned the EPA's ENERGY STAR in recognition of our energy efficient efforts," said North Park Principal Bob Hausmann. "Through this achievement, we have demonstrated to our community and our students a commitment to environmental stewardship while also keeping our energy costs down."

By earning the ENERGY STAR, North Park Elementary School is using about 35 percent less energy than average schools, while still providing comfort to its students, staff, and faculty. The cost effective improvements to the building help in reducing greenhouse gas emissions.

The building was renovated in 2002, during which ground source heat pumps were installed throughout the entire facility. Following startup of the ground source heat pump system, Loup and NPPD assisted the school with reviewing its heating and cooling control system and evaluating its electricity and natural gas consumption.

Its energy performance was found to be very good, and it has maintained that track record over the years.
"The heating and cooling system is the major energy consumer in most buildings. Many buildings have state of the art heating and cooling systems installed but still need maintenance and tuning to keep them running at optimum efficiency," said Rick Cheloha, New Business Supervisor at Loup.
"North Park has a good system that has performed very well over time and the Energy Star designation is testimony to that."
