

# Alumni Association forms partnership with CPS Foundation

In April, the Alumni Association Board of Directors officially joined the Columbus Public Schools Foundation. For alumni wishing to give back to their alma mater, this means that any donations made to the Alumni Association will now be tax deductible for income, gift, and estate tax purposes.

For Brian Christensen, President of the Foundation Board of Directors, the partnership was a natural fit.

"Much like the Foundation, the Alumni Association not only promotes activities for CPS alumni, but also strives to support CPS staff and students and reconnect alumni with current district needs and events," he said.

The Foundation, established in 1985, is a nonprofit, tax-exempt corporation. Their purpose is to solicit, manage, and distribute supplemental funds for educational purposes in program areas that may not be funded by the district. Funding is supplemental, and therefore, does not replace or alter use of tax-based revenue.

Recently, CPS has been forced to tighten its belt with anticipated state and federal budget cuts. As a result, the role of the Foundation – to provide students at CPS with as many educational opportunities as possible by filling gaps created in the regular school district budget from funding shortfalls or regulatory constraints – is becoming more and more important.

Over the last 20 years, the Foundation has distributed more than \$395,000 to CPS. Within the 2010-2011 school year alone, the Foundation has given back \$41,250 in scholarships, award-winning books, student prizes, equipment, and sponsorships.

When it comes to setting goals for the

future, the Foundation has many plans. Teachers have already begun applying for grants that will fund special projects in the 2011-2012 school year. Benches and other enhancements will be added to the East Entrance of the High School where the Foundation-sponsored tree sculpture is featured.

Jessica Kuehler, Executive Director of the Foundation, is looking to establish an annual Teacher of the Year Award with a corporate or private sponsorship. Also in the works are lighting, sound, and other improvements for the Nantkes Performing Arts Center, which will not only benefit CPS students but others in the community who utilize the facility.

# Education & wellness project for Columbus

Many of you may already be aware of the "Quality of Life" joint venture between Columbus Public Schools, the YMCA, East Central Health District, and the City of Columbus. This joint venture is historical in nature for this community and is something new to many communities. If you live in Lincoln, you may have read or noticed the Fallbrook YMCA/Schoo Middle School project. Or, if you live close to Omaha, you may have heard of the Saddlebrook project, which joins an elementary school, library, and community center. Columbus Public Schools is very excited about working with our partners to develop an Education and Wellness campus that will be available to the community for many years.

In July of 2010, the Board of Education purchased 145+ acres of property directly north of Lost Creek Elementary School along 38<sup>th</sup> Street and 33<sup>rd</sup> Avenue. This property was purchased for the sole purpose to house a new middle school building. CPS along with the YMCA, ECHD, and the city interviewed four architectural firms to provide site planning for the land we own. This site plan would start the process of laying out a new middle school, a new YMCA, and a new health clinic. We worked with RVW of Columbus and BCDM of Omaha to provide us with these plans. This process involved interviewing teachers, administrators, and community members to define possible uses for the property.

# Foundation buys equipment for CHS band

The Columbus High School Band Department's need for more music stands has been met. Fifteen music stands, two storage carts, and a conductor's chair were purchased with the Sue Lovci Memorial Fund.

"Since the addition of the highly popular guitar class, and the growth of the CHS Band and Percussion units, it has been necessary to utilize more music stands in both the band and choir room, along with the need to store the new equipment appropriately," said Jeff Peabody, High School Instrumental Music Instructor.

The semester-long guitar class allows the fine arts department to reach more than 100 students each year from an entirely new demographic. Many of these students are not involved in other music classes because they have prerequisites and performance attendance requirements. They choose to take guitar class because it is a music class, which is offered without any of these conditions.

The Susan Lovci Memorial Fund was established through the Columbus Public Schools Foundation to honor the memory of Susan Beth Hollingworth Lovci. Lovci served several terms on the Columbus Public Schools Board of Education and was an outspoken advocate for education. As an accomplished violinist, she was passionate about music programs in the public schools.

With donations from more than 40 individuals, including family and friends, the fund, earmarked for the Columbus High School Music Department, reached \$2,381. The purchase by the CPS Foundation marked the second anniversary of Susan Lovci's passing.

During this time, a citizens' committee was formed called the, Columbus Facilities Advisory Committee. This committee was to develop a community survey regarding the facility needs of the district and investigate if the community would support a bond issue. The committee also recommended that the new facility be built to host grades 5 through 8. The third and most difficult task of the committee was to come up with ideas on the future use of the existing middle school building. A committee will be formed to work on this throughout the bond campaign and after the passage of the bond issue.

The next phase of the project will be to develop a facility program plan. In other words, what are our space needs, program needs, etc. This phase will provide the school district with the necessary information to go to the public with drawings and cost for a bond issue. The board has targeted a bond election for the fall of 2011. If this happens, we will need all of our alumni and staff to be well-informed of the process and project.
